

# PETITION INSTRUCTIONS FOR CIRCULATORS

- Circulators **MUST** be 18 years of age or older. Circulators are not required to be a California resident and are not required to be registered to vote.
- Circulators must **COMPLETELY** fill out the "Declaration of Circulator" **AFTER** collecting the signatures on each petition section. Incomplete declarations will result in rejection of the petition.
- The information must be filled out in the circulators **OWN HAND writing** and information **CANNOT** be pre-printed.
- At all times, circulators **MUST** include the full text of the initiative and the major funders page. Pages cannot be circulated separately and signature pages cannot be added.
- It's a misdemeanor under the California Elections Code to allow signatures on an initiative petition to be used for any purpose other than qualification of the proposed initiative for the ballot.
- Circulators **SHALL NOT** 1) Misrepresent or make false statements concerning the contents, purport or effect of the initiative, 2) Refuse to allow a prospective signer to read the petition, 3) Cover or obscure the Title, Summary or Answer of officer from the view of a prospective signer, 4) Give money or any other item of value to anyone in exchange for his or her signature, 5) Forge signatures or provide false or fictitious information, 6) Refuse to surrender petitions to the Recall District Attorney George Gascon committee.

## DECLARATION OF PERSON CIRCULATING SECTION OF RECALL PETITION (MUST BE IN CIRCULATOR'S OWN HANDWRITING)

- I, PRINT YOUR NAME (You must be 18 years old), solemnly swear (or affirm) all of the following:
1. That I am 18 years of age or older.
  2. That my residence address, including street and number, is Full street address, city, zip where you live. No PO BOX allowed. (If no street or number exists, a designation of my residence adequate to readily ascertain its location is Full street address, city, zip where you live. No PO BOX allowed.)
  3. That the signatures on this section of the petition form were obtained between Start date (Month and Day), 2022 and End date (Month and Day), 2022; that I circulated the petition and I witnessed the signatures on this section of the petition form being written; and that, to the best of my information and belief, each signature is the genuine signature of the person whose name it purports to be.
  4. That I showed each signer a valid and unfalsified "Official Top Funders" sheet, as required by Elections Code Section 107.

I certify under penalty of perjury under the laws of the State of California that the foregoing is true and correct. Executed on Month, Day, Year (Date) at City where you sign this declaration (City or Community Where Signed), California.

# SIGNING INSTRUCTIONS

- **Only voters registered to vote in LOS ANGELES COUNTY can sign petition.**
- **ALL** information must be **WRITTEN IN YOUR OWN HAND WRITING** and not by the circulator.
- Please sign and fill-out information **INSIDE** the numbered box.
- The County Registrar of Voters **DOES NOT ACCEPT** digital signatures, scanned or photocopies of petitions.
- **All petitions MUST be original with wet signatures.**
- Duplicate signers, and non-registered or out-of-jurisdiction voters hurt the validity rate and can jeopardize qualification of the initiative.
